## Article | Bonet and Zamorano on illiberal cultural policies

We spoke with **Lluís Bonet** and **Mariano Martín Zamorano** of the University of Barcelona about their latest research on illiberal cultural policies, published this week in the [International Journal of Cultural Policy](#). These policies are characterized by an exclusionary definition of national culture that is instrumentalized through populist strategies and leads to illiberal practices, which is exemplified by the cases of both Hungary and Poland.

We also discuss the recent restructuring by Victor Orbán's administration of the University of Theatre and Film Arts (SZFE) in Budapest, which led to major protests from its students and faculty. In addition, we briefly touch upon the responsibility of the European Union in tackling discriminatory and authoritarian policies in its member states.
