1. A Message from the Chair

Dear Compendium community!

At the end of the year 2020, in the middle of the odd Covid-19 season, the new Board of the Association of the Compendium of Cultural Policies and Trends took over the responsibility from the previous Board and started to work along with the new Coordinator Kulturpolitische Gesellschaft e.V. to develop further the Compendium project. We started with setting the priorities as a Board, as a Coordinator and as individual Board members.

I would like to share a few highlights from our first year. The updated information and data on the Compendium website appeared as the most significant priority. We realised that all the other priorities are dependent on the Compendium as a valued and updated resource of information. During the year of 2021, several profile updates (long and short profiles) are planned. Along with this, we have developed and presented to the expert's community a transparent expert remuneration system that we hope will contribute and strengthen the expert's commitment. Sustainable financing of the Compendium has been another top priority. Concerning this, we are happy to welcome our three new stakeholder members.

In addition, an important milestone of the year 2021 has been the first Jour Fixe, organised by the Compendium Coordinator in cooperation with the Assembly of Compendium Experts (ACE) and aimed at increasing the role and commitment of the experts. In a way, we can perceive Covid-19 restrictions as an asset that allowed us to have more digital meetings with the Compendium community.

As next important steps, we are now envisaging to increase public awareness of the Compendium as an information and monitoring platform on a national, European and international level, as well as to develop cooperation with other cultural and research infrastructures.

2. Organisation

The *Compendium of Cultural Policies & Trends has more than 20 years of experience* in developing knowledge, research, interaction and exchange in the globalising cultural policy community.

Initiated by the Council of Europe and the ERICarts Institute in 1998 as a transnational project, we transitioned on April 1, 2018 into a multi-stakeholder association "The Association of the Compendium of Cultural Policies and Trends", with the *goal to secure its services for future user generations*.

The **Board of the Compendium Association**, consisting of Association members, supervises the general aims and plans for the Compendium Association. In addition, the Assembly of Compendium Expert (ACE) is also represented in the Board and are key advisors to the (content) development of the Compendium.

The Compendium Association and its platform benefits from an active community of researchers, cultural policy institutes and policy makers. *In 2021, the Compendium Association welcomed three new stakeholder members* with the Ministry of Culture of Luxembourg, the Ministry of Culture of the Republic of Azerbaijan and the Swedish Agency for Cultural Policy Analysis and has now 24 members. From April 2018 to December 2020 the Boekman Foundation (Amsterdam, Netherlands) took over the role of Compendium Service Provider and since January 2021, the *Kulturpolitische Gesellschaft e.V. (Bonn, Germany) became the new Compendium Coordinator* and therefore currently responsible for the daily management of the project.

The Compendium is an independent, transparent and community-based platform freely accessible to all. The Compendium Association and its online information system (**www.culturalpolicies.net**) sees its **objectives and mission** in:

- Empowering cultural policy and cultural research through qualified information and data in these fields
- Providing substantial support to the development of cultural policies by creating better evidence for governments and other actors in the cultural sector
- Enhancing the **international knowledge exchange** and **networking** in the field of cultural policy and cultural research
- Highlighting trends and disseminating best practice cases.

The Compendium offers systematised, qualified and regularly updated **cultural policy related information from currently 43 European countries** for policy makers, researchers, students and journalists.

With the help of **renowned national cultural policy experts**, the **Compendium Platform offers**:

- long and short national cultural policy profiles
- statistics, comparisons and trends
- <u>country reports on current thematic priorities</u> (e.g. COVID-19 measures)
- interviews with stakeholders and cultural policy news
- key documents and relevant information resources.

Baiba Tjarve (Chair, Latvia)



My connections to the Compendium of cultural policies and trends are more than 10 years long being an author of the Compendium profile for Latvia since 2008. Since the end of 2020, I am the Chair of the Board for the Compendium Association.

As to my daily duties, I am a deputy director of strategic planning and development and a leading researcher at the Research Centre of Latvian Academy of Culture. I hold PhD since 2013 and my main research interests relate to intangible cultural heritage, cultural policy

and latest developments in culture. I have been actively engaged in both academic and applied research projects in the field of culture, both on national and international level.

Adrian Debattista (Vice-Chair, Malta)

Cultural policy researcher particularly interested in the interdisciplinarity emerging from the convergence of policy analysis, political discourse theory, popular music studies and the sociology of music. He is currently reading for a PhD in cultural policy at Queen Margaret University, Edinburgh from where he also obtained his MA in Arts and Cultural Management. Presently he also holds the position of Head of Strategy at Arts Council Malta, where he was previously Research Associate, managing the design and

implementation of the Council's strategic framework. Between 2018 and 2020 he formed part of a think tank that developed Malta's national cultural policy document launched in 2021, through public consultation process. As an early-career researcher he has presented in a number of international cultural policy conference over the past five years and co-authored publications that address public funding in culture, volunteering in the arts and audience development. His current



research revolves around the discursive analysis of cultural policy (or its lack thereof) in relation to the social dynamics of music scenes in Malta.

Senior Researcher and Vice-Director at the Center for Cultural Policy Research Cupore in Helsinki, Finland. I have been the Finnish Compendium expert for some years now and was originally brought into the network as co-author by Ritva Mitchell, the former research director of Cupore and one of the founders of the Compendium. Since the end of 2020, I am a member of the Compendium Board and currently the Secretary General. My own research interests include comparative international cultural policies,

cultural heritage issues, the cultural and creative industries, digitalization and arts education.

Andrej Srakar (Treasurer, Slovenia)



Andrej Srakar, PhD (Economics), PhD Candidate (Mathematical Statistics), works as Scientific Associate at the Institute for Economic Research (IER) in Ljubljana and Assistant Professor at the School of Economics and Business, University of Ljubljana. He is Chair of the Association of Compendium Experts (ACE) Board and

Treasurer of the Board of the Compendium Association. He is also Compendium Correspondent for Slovenia jointly with Vesna Čopič and Nika Gričar. He is Coordination Team Member of the Cultural Economics Online Seminar Series (CEOS), Co-Editor of the Cultural Economics & the Creative Economy Book Series for Palgrave Macmillan and was Scientific and Organizational Committee Member of the recent 21st International Conference on Cultural Economics (ACEI). Beside his career as cultural economist, bulk of his work lies in mathematics, on the bound of probability, mathematical analysis, mathematical statistics and econometrics.

Flora van Regteren Altena (Chair CDCPP, Netherlands)



Flora van Regteren Altena is working as a coordinator in the field of multilateral relations (EU, CoE, UNESCO) in the field of culture at the ministry of Education, Culture and Science of the Netherlands in the Arts and Heritage Department. Since 2009, she is member of the CDCPP

and the CDPATEP as delegate for the Netherlands. Since some years she is member of the bureau of the CDCPP and in April 2021 she was

elected by the CDCPP as its Chair. As Chair of the CDCPP she is also Board member of the Compendium Association (the former CDCPP Chair Levan Kharatishvili (Georgia / Ministry of Education, Science, Culture and Sport) was Board member from September 2020 to February 2021). She is trained as an art historian, and have been working earlier in provenance research in relation to returned goods in possession of the Government of the Netherlands returned after the Second World War (Project Origins Unknown), and as an associate expert in the World Heritage Centre, UNESCO from 2003-2006.

Kathrin Merkle (Council of Europe)



Kathrin Merkle heads the Culture and Cultural Heritage Division of the Directorate of Democratic Participation at the Council of Europe and as Secretary to the Steering Committee for Culture, Heritage and Landscape, coordinates the intergovernmental work of 50 states party to the European Cultural Convention. She oversees the work on

Culture and Democracy Indicators, Culture and Digitisation / AI, Freedom of Expression of the Arts and Culture and the Council of Europe's heritage standards, including the Faro and Nicosia Conventions and the European Cultural Heritage Strategy for the 21st century. Trained as a sociologist and political scientist, Kathrin worked for UNESCO Statistics before joining the Council of Europe in 1993. In 1997, she started reflections on a soft monitoring system on cultural policies, which led to the Compendium, developed and run jointly with ERICarts / Bonn until 2018. Kathrin also studied Public Sector Modernisation and Internet Governance issues and remains curious about past, contemporary and future cultures.

Executive Director, European Institute for Comparative Cultural Research (ERICarts); Professor emeritus for cultural policy in Hamburg (but still lecturing at Dresden International University).

He worked first as a journalist in broadcasting, in book publishing, at DER SPIEGEL news magazine and 1972-2008 as Co-Director of Centre for Cultural Research in Hamburg, Bonn and Vienna (ZfKf), with a focus on

cultural professions and arts, heritage and media policies. In collaboration with colleagues, he developed the concept of the "Compendium of Cultural Policies and Trends in Europe" (www.culturalpolicies.net) in 1998/89 and acted as its co-editor until the end of 2017, together with Kathrin Merkle (Council of Europe). Expert for the EU (e.g. Team Leader "Culture-Biz", "Sharing Diversity", "Mobility Matters"); UNESCO; ECF; etc. Missions around the world for development agencies; the Goethe Institute; etc. (Co-)Author or editor of over 50 publications, including "Culture and Human Rights: The Wroclaw Commentaries" (2016).

3. Activities 2021

At the last General Assembly in September 2020, the Kulturpolitische Gesellschaft e.V. as new Coordinator has presented five main strategic priorities for the Compendium Association and its Platform for the timeframe 2021-2023:

- 1. Sustainable financing of the Compendium
- 2. Present more updated information and data on the Compendium Website
- Increase public awareness of the Compendium as an information and monitoring platform and as a European Research Network on a national, European and international level
- 4. Increase the pool of experts within the Compendium, their role and commitment for the Compendium
- 5. Develop more cooperation with other cultural and research infrastructures

What was achieved?

During the first 8 months of 2021, in close cooperation with the new Board of the Compendium Association, several different activities were realised to fulfil these five strategic priorities:

1. Sustainable financing of the Compendium

- Intensification of member recruitment: In 2021, the Compendium Association welcomed already three new stakeholder members with the Ministry of Culture of the Republic of Azerbaijan, the Ministry of Culture of Luxembourg and the Swedish Agency for Cultural Policy Analysis (Kulturanalys).
- **Development of a "List of Benefits"** for members of the Association (see Annex 3) for an even more extensive acquisition of new members for the Compendium Association.
- Consultations with the German contact point Creative Europe Desk regarding the preparation of transnational cultural project applications in 2022 and European Network application in 2023.

- 2. Present more updated information and data on the Compendium Website
 - Development of a new short country profile structure (see Annex 2) in Mai 2021
 - Editing and publishing of 12 updated country profiles (see below)
 - Acquisition of numerous further updates: another
 21 country profile updates confirmed for 2021 (see below)
 - **Publishing of 8 updated Covid-19 reports in 2021** (Albania, Austria, Czech Republic, Ireland, Latvia, Malta, Netherlands, Spain)
- 3. Increase public awareness of the Compendium as an information and monitoring platform and as a European Research Network on a national, European and international level
 - Development of the new format : **Webtalk/Webinar** on selected themes or issues, starting in autumn 2021
 - Concept design and realisation of an Online panel discussion on "What is our crisis and how do we deal with it?" (10th of May)

- Released 8 Newsletters
- Publishing of over 100 Social Media posts
- Presentation of Compendium progress report at the CDCPP plenary session (18th of June)
- Increase the expert's pool within the Compendium, their role and commitment for the Compendium
 - Development of an Experts Remuneration System with the objective of fairness, transparency and adequate compensation of experts work in Mai 2021 (see Annex 1)
 - Concept design and realisation of the first Jour Fixe for Compendium Experts (22nd of June 2021) to enhance the communication and role of experts
 - Preparation, launch of an Open Call for Experts for Luxembourg in August 2021 and implementation of selection process
 - Several individual zoom meetings and other communications with Compendium experts

5. Develop more cooperation with other cultural and research infrastructures

- **Cooperation with ACEI** for the 21th International Conference on Cultural Economics (6th to 9th of July) with a special session for the Compendium
- Preparation of the Cooperation with the UNESCO-Chair Hildesheim for the international symposium on cultural policy (27th to 28th of October) with a presentation of the Compendium

Besides these activities for the five strategic priorities, the Compendium coordinator fulfilled several transition and administrative activities as new service provider since first of January 2021.

Covid 19

Since March 2020, the Compendium is continuously monitoring the impacts of the pandemic crisis with COVID-19 for the cultural sector. With the help of its community of cultural policy expert's eight <u>COVID-19 country reports</u> were updated in the first half of 2021 (Albania, Austria, Czech

Republic, Ireland, Latvia, Malta, Netherlands and Spain) and additional updated COVID-19 country reports will be published in the second half of 2021. Beside the country reports, the Compendium offers <u>comparative overviews of financial</u> <u>measures</u> as well as <u>reopening measures</u> in the context of COVID-19 in different countries.

The COVID-19 country reports and comparative tables have proven their quality and importance as their information and data were majorly used in different comparative research studies on a European level. Two prominent examples are the study for the European Commission on <u>The Assessment of the Impact of COVID-19 on the Cultural and Creative - Sectors in the EU's Partner Countries, Policy Responses and their Implications for International Cultural Relations realised by the Cultural Relations Platform in March 2021 and the study for the European Parliament on <u>Cultural and creative sectors in post-</u> <u>COVID-19 Europe – Crisis effects and policy recommendations</u> published in February 2021.</u>

As a next step, the Compendium will collect impact studies from the different European countries in order to analyse and monitor the mid- and long-term consequences of COVID-19 for the cultural sector, such as the developments regarding the cultural infrastructure, cultural participation and the situation of artists and cultural workers.

4. What is next?

According to the Conceptual Plan 2021 – 2023, that has been presented and discussed at the General Assembly in September 2020, the Compendium Coordinator is following the above-mentioned five strategic priorities and additionally aim at strengthening the Compendium community building.

In 2021, the focus was on updating the country profiles including developing a new structure for the short profiles and increasing the number of short profiles in response to user needs. This will be continued and work in the next 2 years will be focused on expanding the communication with members and experts and new cooperation partners, improving the statistic and comparison section on our website, increase visibility for the Compendium via events and social media and ensure the sustainable financing via the acquirement of new members as well the participation in Creative Europe Calls. In detail:

1. Sustainable financing of the Compendium

- Acquire new members for the Compendium association
- In Summer 2022, a first Creative Europe application for Transnational Cooperation Projects will be submitted

2. Present more updated information and data on the Compendium Website

- Develop new comparative and statistical tables and update existing ones
- Continue country profile updating efforts
- Collect national Covid-19 impact studies from the different European countries in order to identify trends regarding the cultural infrastructure, cultural participation and the situation of artists.
- Define new annual topics for 2022 and 2023 and publish material
- 3. Increase public awareness of the Compendium as an information and monitoring platform and as a European Research Network on a national, European and international level
 - Organise around 10 Compendium Webtalk/Webinar on selected themes or issues in 2022 and 2023
 - Organise and contribute to cultural policy related conferences or panels in cooperation with strategic partners with the goal to promote the Compendium

- Hold a General Assembly in Bucharest (Romania) in 2022 in cooperation with the National Institute for Cultural Research and Training Romania
- Improve the Compendium website (Analysis by a communication expert and search engine optimisation)
- Intensify the social media activities
- Enhance the number of referral website links with cooperation partners and actors in the cultural policy field
- Present Compendium progress at the CDCPP sessions
- 4. Increase the expert's pool within the Compendium and their role and commitment for the Compendium
 - Develop an open database for cultural policy experts and actors in order to enhance the pool of experts
 - Run an Open Call for Experts for Russia and San Marino in Autumn 2021
 - Run an Open Call for Experts for Bosnia and Herzegovina, Denmark, Greece, Holy See, Iceland, Moldova, Slovakia in 2022
 - Organise 1-2 Jour Fixe for the Compendium Experts

- 5. Develop more cooperation with other cultural and research infrastructures
 - Develop new project initiatives in order to increase the cooperation with other Pan-European cultural organisations.
 - Enhance the Compendium network by increasing the number of Compendium partners
 - Organise and contribute to cultural policy related conferences or panels in cooperation with strategic partners
- 6. Strengthen Community building of the Compendium family
 - Enhance communication with the members of the Compendium Association with the goal to improve their visibility, identify their demands and develop services in this context
 - Create a "solidarity fund", which is fed by the unused fees of experts

5. Audience Overview

Since the launch of the new Compendium website in December 2019, the audience figures stay at a good and stable level. In the tables presented below, you can see that in the second half of 2020, the number of page views dropped but could be balanced in the first half of 2021 to over 100.000 page views. The session per users have raised from 1,65 to 1,74 and the average duration session is at 03:40. The bounce rate stay constantly at around 50%, which is a good but still improvable figure. The number of social media followers is constantly growing (2021: Facebook over 10%, twitter over 40%) and the number of Compendium Newsletter subscribers augmented in 2021 by 3% and reached nearly 4 000 subscribers.

The Compendium's most popular pages are the cultural policy profiles with more than 20 percent, the homepage with more than 15 percent and the COVID-19 section with more than 10 percent. A major audience source are organic search entries with around 30% (search results via Google and other search engines), direct entries with nearly 20% (visitors who know the Compendium), referral entries with over 15% (visitors entering the Compendium website from external weblinks) and referral entries via social media with around 10% (visitors entering the website via social media).

The Coordinator see clear potentials to enhance the audience figures of the Compendium website. In 2022, after the quality of the content of the Compendium website has been enhanced through the presentation of several updated country profiles and new statistical data the following activities are envisaged to improve the audience development of the website:

- The Compendium website will be analysed by a communication expert
- A search engine optimisation (SEO) will be made
- Social media activities will be further intensified
- The number of referral website links with cooperation partners and actors in the cultural policy field will be enhanced

Beside the website optimisation through a communication expert, the Coordinator see the need to make the Compendium, its knowledge and information, expert's pool and members more visible. Therefore, we want to:

- Increase the number of cooperation agreements and partners
- Start Compendium webinars in September 2021

Annex 1: Experts Remuneration System



Expert's Remuneration 2021

NOTE: A major priority of the Compendium Coordinator and the Board of the Compendium Association is to maximise the general and individual expert's remuneration in the framework of the existing budget.

According to the Financial Plan 2021, the Coordinator has originally planned a budget of 45.000 EUR for the remuneration of the Compendium experts. This provisional budget is applicable as long as all members pay their full membership fee and no stakeholder member withdraws its membership to the Compendium Association.

According to the recent communication with the individual Compendium experts, the Coordinator expects up to 29 country profiles updates for 2021 of which 20 are planned updates (11 LP updates and 9 SP updates) and 9 are potential updates (8 LP updates and 1 SP update).

The Coordinator developed a matrix for the expert's remuneration where the earmarked 45.000 EUR are allocated to the 29 planned and potential country profile updates in 2021. The matrix gives an overview of the expert's remuneration according to two variables:

- the type of product; and
- the quantity and quality of the product delivered by the expert.

There are currently **5 types of products** that the expert can be remunerated for and which demand a different amount of work to deliver the product:

- 1. creation of a first long national cultural policy profile,
- 2. updating of a long national cultural policy profile from the old grid to the new grid,
- 3. updating of a long national cultural policy profile form the new grid to the new grid,
- 4. creation of a first short national cultural policy profile, and
- 5. update of a short national cultural policy profile

The **quantity and quality of the product** delivered by the expert is classified in 3 categories (higher rate, standard rate and reduced rate). Besides theses 3 categories of remuneration there exist an extra option of in-kind contributions / donations for all types of products (e.g. for experts who are not in the need to receive remuneration, because they undertake their work from their affiliation at an institution).

The reduced rate applies only for very small countries (e.g. San Marino, Liechtenstein, Monaco, Holy See and Andorra).

The standard rate applies to all other countries who have fulfilled the regular standards of quality and quantity regarding updated information as mentioned in the contractual agreement with the individual expert.

The higher rate is given to experts who deliver a very good product according to the following 3 factors:

- Priority of the country profile update. Strongly outdated country profiles negatively affect the quality of the Compendium as information system (country profiles not updated > 5 years have a high priority; country profiles not updated > 2 years have a medium priority; country profiles not updated < 2 years have a low priority)
- 2. In the context of the editorial review process, the Coordinator with its long-term experience in evaluating European cultural policy reports can determine if the cultural policy content delivered: is of high quality (very good analytical and descriptive reporting); has a good quantity (reached a minimum number of characters and not exceeded the maximum number of characters in the individual chapters and sub-chapters)
- 3. Special conditions in a country such as aspects of current political changes (e.g. government changes and/or new cultural policy structure), a difficult political situation (in certain countries the political circumstances negatively affect the working conditions of the expert, e.g. Russia Federation) or is rather complex to describe (higher amount of reporting due to political structure of the country e.g. federal state or the country has a high level of cultural policy development or history which can also mean a higher amount of reporting)
