## **Updated Cultural Policy Profile for Poland**

Thanks to the enormous efforts of our experts Dorota Ilczuk and Anna Karpinska from the Creative Economy Research Center at the SWPS University in Warsaw, an updated cultural policy profile from Poland is now available on the Compendium!

It contains updated information on recent cultural policy developments in Poland such as the difficult situation of cultural industries and artists, caused by the COVID-19 pandemic outbreak (chapter 2.1, chapter 2.7), the situation in the context of cultural rights (chapter 2.2), aspect of cultural sustainability (chapter 2.8), research on the labor market of artists and creators in Poland (chapter 2.9) and most recent data on cultural participation and household expenditures on culture (chapter 6.2 and chapter 6.3) as well as recent data on public cultural expenditures (chapter 7.1).
