# 2. Organisation

The Compendium of Cultural Policies & Trends has 25 years of experience in developing knowledge, research, interaction and exchange in the globalising cultural policy community.

Initiated by the Council of Europe and the ERICarts Institute in 1998 as a transnational project, we transitioned on April 1, 2018 into a multistakeholder association "The Association of the Compendium of Cultural Policies and Trends", with the **goal to secure its services for future user generations.** 

The Compendium is an independent, transparent and community-based platform, freely accessible to all. The Compendium Association and its online information system <a href="https://www.culturalpolicies.net">www.culturalpolicies.net</a> sees its objectives and mission as:

- **Empowering cultural policy and cultural research** through qualified information and data in these fields
- Providing substantial support to the development of cultural policies by creating better evidence for governments and other actors in the cultural sector
- Enhancing the **international knowledge exchange and networking** in the field of cultural policy and cultural research
- Highlighting trends and disseminating best practice cases.

The Compendium Association and its platform benefits from an active community of researchers, cultural policy institutes and policymakers.

The Compendium platform offers systematised, qualified and regularly updated cultural policy related information from, currently, 45 European countries (+ 10 additional countries) for policymakers, researchers, students and journalists.

With the help of renowned national cultural policy experts, the Compendium Platform offers:


- Long and short national cultural policy profiles

Baiba Tjarve (Chair, Latvia)

Since 9/2020

Baiba Tjarve's connections to the Compendium of cultural policies and trends span more than 10 years, being an author of the Compendium profile for Latvia since 2008. Since the end of 2020, I hold the Chair of the Board for the Compendium Association.

Baiba is a Deputy Director of Strategic Planning and Development and she is a leading researcher at the Research Centre of Latvian Academy of Culture. Baiba holds a PhD since 2013 and her main research interests relate to intangible cultural heritage, cultural policy and the latest developments in culture. She has been actively engaged in both academic and applied research projects in the field of culture, both on national and international level.

#### Adrian Debattista (Vice-Chair, Malta)

Cultural policy researcher, particularly interested in the interdisciplinarity emerging from the convergence of policy analysis, political discourse theory, popular music studies and the sociology of music.



Adrian is currently reading for a PhD in cultural policy at Queen Margaret University, Edinburgh, from where he also obtained his MA in Arts and Cultural Management. Presently he also holds the position of Head of Strategy at Arts Council Malta, where he was previously Research Associate, managing the design and implementation of the Council's strategic framework.

Between 2018 and 2020, Adrian formed part of a think tank that developed Malta's national cultural policy document launched in 2021, through a public consultation process. As an early-career researcher, he has presented at a number of international cultural policy conferences over the past five years and co-authored publications that address public funding in culture, volunteering in the arts and audience development. His current research revolves around the discursive analysis of cultural policy (or its lack thereof) in relation to the social dynamics of music scenes in Malta.

#### 3. Activities in 2022 and 2023

The Kulturpolitische Gesellschaft e.V. as Compendium Coordinator is focussing its activities on six main strategic priorities for the Compendium Association and its Platform for the timeframe 2021-2023:

- 1. Sustainable financing of the Compendium
- Present more updated information and data on the Compendium website
- 3. Increase public awareness of the Compendium as an information and monitoring platform
- 4. Increase the pool of experts within the Compendium, their role and commitment to the Compendium
- 5. Develop more cooperation with other cultural and research infrastructures
- 6. Strengthen community building of the Compendium family

#### What was achieved?

Since the last General Assembly in July in close cooperation with the Board of the Compendium Association, its members and experts several different activities were realised to fulfil these six strategic priorities:

- 1. Sustainable financing of the Compendium
  - Stabilize the number of members: Despite the Covid19pandemic and the financial challenges it presented, we were able to maintain the number of members of the Compendium Association: 25
  - Aquise activities for new members: In addition, we are in talks with other countries to increase the number of stakeholder and standing members even further in the future
  - Application for the UNESCO Aschberg Call with the copartners: BIE-Network + Arts Rights Justice Programme of the UNESCO-Chair of Hildesheim – in February 2023
  - Application to the Open Call of the ifa programme
     »Culture and Foreign Policy« on »Safeguarding of
     Artistic Freedom« in June 2023

- 2. Present more updated information and data on the Compendium Website
  - Editing and publishing of 26 updated country profiles since the last General Assembly (see below)
  - Publishing of **5 updated Covid-19 reports** in 2022/2023
  - Launch of Campaign Freedom of Artistic Expression in December 2022 with papers, background material and a survey (see below)
  - Develop a renewed indicator system and release of a CUPIX <u>Table</u> on Price Levels of Cultural Goods and Services 2022 in May 2023
  - Publication of several "News from the Members" posts in 2022 / 2023 on the Compendium website featuring national cultural policy related information
  - Restructuring the Compendium website for the new campaign "Freedom of Artistic Expression" and for the presentation of profiles of new countries
- 3. Increase public awareness of the Compendium as an information and monitoring platform and as a European Research Network on a national, European and international level
  - Prepared and organised an International Cultural Policy Conference and 6th General Assembly in Malta from the 4th to the 6th of October 2023 in cooperation with the Maltese member: The Arts Council Malta
  - Released 7 Newsletters since 2022 (among those 5 since the last General Assembly)
  - Published around 200 Social Media posts in 2022/2023

- Develop, create and launch new formats for Instagram: since June 2023 Compendium is on Instagram – with short explanatory videos by our new project assistant Leonard Mertens
- Presentation of Compendium progress report at the CDCPP plenary sessions in Strasbourg (24th November 2022) – with very positive feedback from numerous members of the CDCPP
- Participation on the international conference »Free to Create - European Union Conference on Artistic Freedom and Cultural and Creative Industries« in Umeå 15th-17th February 2023
- Representation of the Compendium at the 9th World Summit on Arts and Culture in Stockholm 3rd-5th May 2023
- Presentation of the Compendium at the International Conference »In from the Margins« of the University of the Arts in Belgrade 26th-28th June 2023
- 4. Increase the expert's pool within the Compendium, their role and commitment to the Compendium
  - Organising and realizing of the ACE-Assembly on the 14th of November 2022 in cooperation with ACE
  - Release of an Open Call for Experts for Moldova in November 2022 and welcome of our new expert from Moldova
  - Welcome new co-authors from Serbia, Spain and the Netherlands
  - Several individual zoom meetings and other communications with Compendium experts

# 5. Develop more cooperation with other cultural and research infrastructures

- In 2023, continuation of the cooperation with EGMUS (European Group for Museum Statistics) as e.g. taking part at their annual meeting + other Zoom-Meetings
- Conversations for building up a partnership with Culture
   Action Europe with its new Secretary General
- Conversations with IFACCA to explore further options of exchange
- Conversations with EUROSTAT and its new statistical officer for cultural issues to explore further options of exchange

#### 6. Strengthen Community building of the Compendium family

- Realisation of the Jour Fixe of the Members: 14th of April 2023 in order to improve communication with members, obtain their feedback and ideas for the Compendium
- Realised over 20 individual zoom meetings with members of the Compendium Association with the goal to identify their wishes and improve their visibility within the Compendium, which will be continued
- Continuation of a "Support Fund for Compendium Experts", which is supported by the unused fees of experts

Besides these activities for the six strategic priorities, the Compendium coordinator co-operated constructively with the Board (i.e. prepared and organised the Compendium Board meeting, including agendas, activity reports and minutes).

# From COVID-19 to Freedom of Artistic Expression

When the COVID 19 crisis erupted, the Compendium initiated the first campaign to identify the impact on the European cultural sector and its policies and to learn from each other's measurements of support. This initiative led to more than 30 country members publishing a "COVID 19 Update Report" monitoring the crisis management of their respective countries. The aim was to quickly share and compare experiences in order to speed up adaptation processes in case of further pandemic waves.

After the WHO announced the end of the COVID-19 pandemic in 2022, the Board of the Compendium Association defined Freedom of Artistic Expression as an annual topic. It is a matter of major interest for the Compendium and its community observing that Freedom of Artistic Expression is challenged / in danger in times of war, pandemic, or an increase in populist and anti-democratic tendencies. For the Compendium, as well as all other art and cultural actors, it is an important concern to highlight the importance of freedom of artistic expression as a fundamental element of cultural policy for the preservation of an open-minded, healthy and free society.

That's why the Compendium's focus for this year is a <u>cultural policy research</u> <u>campaign "Silencing Dissent? – On Barriers to Freedom of Artistic Expression"</u>. The campaign takes a critical look at the status quo of today's freedom of artistic expression and an open exchange about the barriers that limit the creative diversity of artists.

As a basis for the campaign, <u>Andreas Joh. Wiesand</u> wrote a series of four articles for contextualising, highlighting the main instruments and stakeholders and exploring various barriers related to freedom of artistic expression (e.g. political climate, censorship, social and community pressures). In addition, a collection of material on stakeholders, studies e.g. was published. Finally, an expert's survey was realised in summer 2023, the results of which will also feed into the debates at the Compendium conference in Malta.

#### 4. What is next?

As the previous chapters show, the Compendium has realised also in the last year various activities and initiatives in 2022/2023 and continued its positive development, thanks to the valuable help of its members and experts. The development is framed by the six strategic priorities for the 3-year period brought in by the new Compendium Coordinator which took over its task in January 2021.

Overall, the Compendium Board and the Compendium Coordinator assess the development of the Compendium Association and its platform/website as positive and successful.

However, in line with the mission statement and values of the Compendium Association, and out of a commitment to the Compendium and its community of practice, we believe that there are even more opportunities to further develop the cultural policy monitoring tool.

In this context, we welcome any new ideas and initiatives from our valuable Compendium members and experts. Below you can find different potential activities and initiatives worth discussing and elaborating in the coming years:

#### **Visibility**

- Develop a Compendium Ambassadors' Programme with the intention of facilitating connection to individuals dedicated to the Compendium and its promotion
- Expansion of information in original languages on the website (using AI)
- Define a new thematic focus of the Compendium after Covid-19 (2020-2022) and Freedom of Artistic Expression (2022-2023)

 Optimising the Compendium Website regarding its functionality, user friendliness and up to date visual elements

#### **Capacity building**

- Develop "capacity building seminars/workshops" in cooperation with the Compendium experts and cooperation partners regarding specialised themes in the field of cultural policy. Target group being civil servants, cultural administrators, cultural policy makers or »newcomers«/next generation.
- Develop a "Database of Training Programmes for Cultural Policy Research in Europe"
- Cooperation with Universities on PhD programme on Cultural Policy
- Building up a peer review process of the country profiles in cooperation with Assembly of Compendium Experts (ACE)

#### **Statistics**

- Reset the statistics section with new or updated comparative or statistical tables
- Intensify the cooperation with Eurostat

#### **Research Activities**

- Built up networks with other European Associations to develop research projects (e.g. cultural infrastructure)
- Apply for international research funding in correspondence with the annual topics
- Conduct own surveys in correspondence with the annual topics
- Develop new visual elements

#### **Enlargement of the Compendium**

- Enlargement of the Compendium community among both members and experts
- Discuss "Compendium goes beyond Europe"

## 5. Audience Development

The user figures for the Compendium website are good and constantly growing: the page views increased from 165 896 to 172 788 (see table on next page).

Other **main user figures kept relatively constant**, such as the sessions per user, the average duration of sessions and pages per session (see below).

The **bounce rate rose** from 55% to 63%, which is a figure that calls for improvement.

**Growing number of Compendium Newsletter subscribers**. From 4 113 to 4 895, growth of 19%.

Compendium has an increasing number of social media followers. In August 2023, the Compendium reached 4 265 Facebook followers (compared to 2022, a growth of 4% and compared to 2018, a growth of 73%). At the same time, the Compendium reached 714 followers on Twitter (compared to 2022, a growth of 30% and compared to 2019, a growth of 1 457%). In August 2023, the Compendium LinkedIn channel had 450 followers.

**New Instagram account for the Compendium.** The new project assistant Leonard Mertens has started promoting the Compendium via Instagram with video clips in order to improve visibility and find new users for the Compendium. In August 2023, the Instagram account had 50 followers.

**Most popular content of the Compendium website:** 30% country profiles, 20% cultural policy news, 15% Campaign on Freedom of Artistic Expression and Covid-19.

**Major source of Compendium website entries:** 35% organic search entries (via search engines such as Google), 25% direct entries (users who know the Compendium), 20% referral entries (users coming from external web-links) and 15% referral entries via social media (users entering the website via social media).

**Potential to improve the audience figures of the Compendium website**: initiate a search engine optimisation (SEO), intensify social media activities, improve number of referral weblinks.

Improving the awareness of the Compendium Association, of its knowledge and information platform as well as to enhance the visibility of its members and experts is a basic objective.

Therefore, the Compendium Coordinator will continuously enhance cooperation and promotional activities.

#### **Description of New Social Media Format**

The Compendium Coordinator in agreement with the Board of the Compendium Association has launched a new Social Media account on the platform **instagram**. The handle of the account is as follows: **compendium\_cp**.

#### **Goal and Strategy:**

Through the new Social Media account the Compendium is trying to reach a new target audience, composed of young people with an interest in cultural policy. The posts on the platform differ from the content the Compendium puts out on Facebook, Twitter and LinkedIn. It has a stronger emphasis on explaining certain aspects of the Compendium, like the cultural policy profiles, or the research campaign.
